#### FINANCIAL STATUS OF THE SOCIETY

#### **GRANT COMMITTEE**

The Board of Directors, in: response to numerous requests for funds from the Society, has established a "Grant Committee" to review such requests. The Board has also enacted policies and procedures regarding the awards of grants. Any member who wants a copy of the policy? and procedure statement may: call our office or drop us a note. Any members wishing to serve on the Grant Committee should contact the president of the Society, who is responsible for all committee appointments.

### Gift to Goethe Society

The German Society has given its support to the fledgling Maryland Chapter of The American Goethe Society by a \$25 gift for its activities. The Goethe Society president is Brigitte Fessenden, who is also a director of the our Society. The Goethe Society presented an illustrated lecture at Towson State Univ. in February, by Dr. Beicken, of the University of MD, College Park. The subject: the Prague years of German author Franz Kapfka. Many members of our Society were in attendance. A favorable review of the lecture, by German Society member Dr. Armin Mruck, was published in the March 8th issue of the Washington Journal.

Ronald Antilitz, CPA and John Ensor, investment counselor, both members of the Board of Directors, prepared reports of the finances of the Society for presentation at the annual meeting of the membership. As of March 4, 1996, our general fund portfolio now stands at \$388,446 and our scholarship fund stands at

\$199,411. Since last year, the general fund has increased by 18.2% and the scholarship fund by 20.4%. Our successful investment decisions have been based upon the recommendations of John Ensor, a stockbroker and member of our finance committee.

#### **SCHOLARSHIP FUND**

The scholarship fund was established in 1985. At that time the Board of Directors set a goal of raising a special fund of \$150,000 by way of contributions from the general fund. That goal was reached in 1994 and scholarships since then have been paid from the income of that fund, thus making income from the general fund available for other projects of the Society. We are now concentrating our earnings from the general fund on promoting German language studies at the high school and lower levels, and on heritage and genealogy programs.

### Festival Culture Booth Earns Money

The German Society received the maximum credit of 60 manhours for maintaining our culture booth at the Summer German Festival. Manhour earnings are based on a percentage of the profits from the event. We received \$323 for our service. The principal goal of the Society in participating in the Festival was the spreading of information about the works of the society and distributing genealogical and cultural materials. The cash earnings were a bonus.

Past President Ted Potthast thanked Mrs. Awalt for her service at our annual meeting and said that during her term on the board as chair of the genealogy committee, the Society made substantial advances in our genealogy program under her leadership.

### ALBERT CRAEMER, DIRECTOR 1980 TO 1996

The Society gratefully acknowledges Albert Craemer's many years of service as a member of our Board of Directors.

Albert came to the USA from Germany as a young man in the 1950's. He was trained in Germany in hairdressing and resumed that occupation in Baltimore. He currently owns a successful salon in Pikesville.

Albert devoted much time to the old Deutches Haus where he became well known to the German-American community of Maryland. After the Deutsches Haus was torn down by the City to build the Meyerhoff Concert Hall, Albert launched a personal crusade to find another place to serve as a center for the German community. He leased a large building next to the Shot Tower across from the main post office in the city and opened a German restaurant and meeting place. The German Society contributed \$5,000 to the project for the construction of a German meeting hall in the building. Unfortunately, the location and the timing acted against the project, forcing Albert to close down after a couple years.

Albert has a scholarly bent and is an avid book collector. His private library contains more than 10,000 volumes. During his years as a Director, Albert participated in many projects. He was highly sensitive to the problems of aging German immigrants. Often he brought their plights to the attention of the directors, which could sometimes assist with relief. He served as the "conscience" of the Board. Albert offered his

personal aid to immigrants who found themselves and their families stranded here.

### Six Years After the Fall of the Berlin Wall

Within a few weeks after the Berlin Wall came down, the German Society of Maryland rushed to sponsor an ecumenical service of thanksgiving for the reunification. Relations between the east and west Berliners has not gone as smoothly as was hoped. The following is an excerpt from an article by Richard Atcheson, entitled "Return to Berlin" in the April, 1996 issue of Modern Maturity, the magazine of AARP:

"The chasm between East and West Berliners -- the *Ossis* and the *Wessis* -- is wide and deep. The divisions are social, economic, moral, spiritual, right across the board. The general Wessi view is that the Ossis are shiftless and clueless, excluded for so long from the rhythms of the West that they just don't know the moves.

The Ossis feel shut out. Since reunification they speak of wanting to have "their" '60's -- "their" ebullient epoch of new cars and trips to Majorca. And where's the money coming from? the Wessis wonder. The Ossis are busted, lucky to have crosstown carfare. Wessis pay higher taxes to fuel the rebuilding of the East, and they resent it.

So crossing town doesn't happen as much as you'd think. "There was a lot at the beginning" says a friend, "but it fell off fast. They do things their way, we do things our way." The Ossi way is to be friendly and glad to see you, eager to talk; Wessis could care less whether you're there or not. Ossis think Wessis are snobs, which they are. And Wessis regard Ossis as goofs, which I'm not at all persuaded of. (I actually like it when people are nice to me.)

Ossis and Wessis alike have said to me that everybody who remembers the Wall will have to be dead before Berlin has a common heart again."

#### **REPORT #43 TO BE RELEASED**

In the 110 years of the existence of the Society for the History of the Germans in Maryland, 42 volumes of its publication "The Report" have been issued. Within the month, that Society will publish volume 43, which is reported to contain the most articles and be the biggest volume yet issued in the history of organization. Board of Directors of The German Society of Maryland voted a \$1,000 contribution to assist in the publication of this historic issue. Dr. Randall Donaldson, professor of German at Loyola College, is the editor of The Report. Judge Gerard Wittstadt is president of the Society. Judge Wittstadt commended Dr. Donaldson for his efforts in obtaining so many scholarly and interesting articles of this unique edition.

### HISTORICAL SOCIETIES SEEK FUNDS

A national historical society, the Society for German-American Studies. and а Maryland historical society, the Society for the History of the Germans in Maryland, are both raising money for publication funds. The Society for the History of the Germans in Maryland has established a trust fund to assure the continuation in perpetuity of its publication, The Report. While most other ethnic societies from the 1900s are now defunct, the latter society, established in 1883, has published 42 issues in its 102 years of existence. It publishes scholarly articles whenever it has enough articles to make it worthwhile, and enough money to print them. That is the secret of its success, according to Prof. Harold Jahn, (now deceased) its former editor and a Professor of German at Johns Hopkins University. The Maryland Society is half-way to reaching its goal of \$50,000. The Society for German-American Studies, established in 1968, is also half-way in reaching its goal of \$100,000. It publishes the Yearbook of German-American Studies. German Society of Md. to these scholarly efforts may call our Society's office information.

### GERMAN SOCIETY HELPS HIBERNIANS CELEBRATE

The German Society was represented at the

annual banquet of the Hibernian Society by President Ted Potthast. This year's event was held early, on March 14, since the usual festival day of the Irish, St. Patrick's Day, fell on a Sunday. The Hibernians and the German Society have had close ties for over 150 years. In the early 1800's, before the days of DSS's (Departments of Social Service) and public assistance the problems of immigrants were handled by private organizations. The City of Baltimore collected a \$2 head tax on each immigrant entering the port. The German Society receive 50¢ for each immigrant from Germany, Austria and Switzerland, and the Hibernians received 50¢ for each Irish immigrant. Over the years our Society received over \$35,000 from the head tax, which was used to aid the immigrants. The Hibernians received

### **HISTORICAL NOTES**

### MAYOR OF BALTIMORE INCORPORATOR



Jacob Small, a member of the German Society of Maryland, while serving as Mayor of

Baltimore in 1817, acted as one of the twenty two incorporators of the Society. The incorporators also included General John Stricker, the hero of the War of 1812 Battle of North Point and founder of the Bank of Baltimore.

### CONSTITUTION OF THE SOCIETY

Article XIV of the Constitution of the Society, registered with the Secretary of State of Maryland in 1879, reads as follows:

ARTICLE XIV
"Non-Acceptance of Office

If any member elected to an office, refuses to serve therein, he shall pay a fine of ten dollars into the treasury, unless he has alread served in the same office, or paid the fine for non-acceptance."



### JUSTICE IN FREDERICK MD DURING REVOLUTION

Frederick was a center for holding Hessian prisoners during the revolution. It was not an easy time to be on the wrong side of the law in Frederick.

In the series American Historic Towns Published by G. P. Putnam Sons in 1900, it is reported that seven Tories were convicted of treason in Frederick Town and the following sentence was passed upon them:

"You shall be carried to the gaol in Frederick town, and be hanged therein; you shall be cut down to the earth alive, and your entrails shall be taken out and burned while you are yet alive. Your heads shall be cut off; and your body shall be placed where His Excellency the Governor shall appoint. So Lord have mercy on your poor souls."

The author comments: "This terrible sentence was in four instance executed!"

### **RECHTSCHREIBREFORM**

Last month the German government approved a set of 112 rules on writing, from how to spell foreign words to where to place comma. a "Rechtschreibreform" - Reform of the Right Way to Write, drafted by the ministry of culture. was presented to the 16 German states, which accepted it without objection. France has similar laws, for which offenders are taken to court and fined. Germany imposes no fines for violations of good grammar. Imagine the turmoil which the ACLU would cause in America if our government tried to dictate spelling and grammar!
